- *Donald A. Gifford Alumni Service Award: Full-time USF employees are eligible.*
- *Outstanding Young Alumnus Award: Nominees must not have reached age 36 by January 1<sup>st</sup> of the award presentation year.*
- *Eligibility is limited to living persons*
